TERMS AND CONDITIONS OF USE OF SATREF DATA SERVICES FOR REGISTERED USERS

1. “SatRef Data Services” (the “Services”) means the following specified services made available for Registered Users (as defined below) under the Hong Kong Satellite Positioning Reference Station Network System (“SatRef”) by the Survey and Mapping Office of the Lands Department of the Government of the Hong Kong Special Administrative Region (the “Government”):-
 - Network Real Time Kinematic (RTK) Service; and
 - Differential GNSS (DGNSS) Positioning Service.

Use of SatRef Data Services for Registered Users

2. Unless otherwise stated in these Terms and Conditions of Use of SatRef Data Services for Registered Users (“Terms of Use”), you are allowed to use the Services for both commercial and non-commercial purposes on a free-of-charge basis, on the condition that:-
 - you shall comply with the Terms of Use;
 - you shall register as a registered user of SatRef Data Services (“Registered User”); and
 - you shall indemnify the Government against any allegations or claims of infringement of the intellectual property rights or any other rights of any person and all costs, losses, damages and liabilities of whatsoever nature suffered or incurred by the Government, arising directly or indirectly out of, in connection with or in relation to your use of the Services.
3. In paragraph 2, “commercial purposes” includes without limitation the following:
 - an offer to supply goods, services, facilities, land or an interest in land;
 - an offer to provide a business opportunity or an investment opportunity;
 - an advertisement or promotion of goods, services, facilities, land or an interest in land;
 - an advertisement or promotion of a business opportunity or an investment opportunity;
 - an advertisement or promotion of a supplier, or a prospective supplier, of goods, services, facilities, land or an interest in land; and
 - an advertisement or promotion of a provider, or a prospective provider, of a business opportunity or an investment opportunity,in the course of or in the furtherance of any business.

4. The Services are provided by the Government to you on an “AS IS” basis. No statement, representation or warranty of any kind (whether express or implied) is given by the Government in relation to the Services (including without limitation the accuracy, completeness, non-infringement, reliability, security, timeliness and appropriateness of the Services for use for any purposes or in any particular circumstances). The Government shall not be liable for any errors, omissions, misstatements or misrepresentations (express or implied), concerning any Services, and shall not have or accept any liability, obligation or responsibility whatsoever for any loss, destruction or damage (including without limitation consequential loss, destruction or damage) howsoever arising from or in respect of any use or misuse of or reliance on the Services, or any inability to use the Services.

Registration

5. Login ID and initial password of the account will be sent to the email address provided in the application form after successful registration.
6. The Registered User may authorise any person to access and use the Services on its behalf, and may divulge to its authorised persons the login ID and password issued to it for such purpose.
7. The Government shall be under no obligation whatsoever to investigate or verify the authority of persons using the Registered User’s login IDs.

Termination

8. The Government may reserve the right to immediately terminate your account as a Registered User without prior notice in the event of any of the following occurrences:
 - (a) The Registered User has not used the Services for a period of time specified in Geodetic Survey Website.
 - (b) The Registered User’s excessive usage of the Services results in abnormal traffic that causes significant interruption to the Services.
 - (c) It was found that the account was used for any purpose that is unlawful, or in violation of or prohibited by these Terms of Use, or to solicit the performance of any illegal activity or other activity which infringes the rights of the Government or others.

Users' Obligations

9. Without prejudice to the generality of the other terms and conditions herein, the Services shall not be made available to the Registered User unless the Registered User has acquired and made available the necessary hardware, software and communications link. The Registered User shall be solely responsible for these arrangements and shall enter into such contracts and bear all expenses as may be required by any provider of the hardware, software, network and communications link and the Government shall not be responsible for any obligations, expenses or liabilities incurred or suffered by the Registered User in connection therewith.

Personal Information Collection Statement

10. (a) The personal data you provided by means of this form will be used by the Government for the following purposes:

Please note that we may refuse to comply with a data access request in the circumstances specified in section 20 of the Personal Data (Privacy) Ordinance (Cap. 486).

15. The Government reserves the right to add to, delete and/or vary the Terms of Use, upon one calendar month's notice being given to the Registered User.

Governing Law

16. The Terms of Use shall be governed and construed in accordance with the laws of the Hong Kong Special Administrative Region of the People's Republic of China ("Hong Kong"). You also agree to submit to the exclusive jurisdiction of the Hong Kong Courts.
